The PhD student must have:

1. spent at least three months of study and/or research aimed at preparing the thesis at a university or research institution in a European country within the third year of attendance of the PhD course and before admission to the final exam;
2. presented suitable certification for the above period;
3. appropriately completed and submitted the admission form for the final exam;
4. obtained a favorable opinion from the PhD Teaching Committee on issuing the attestation;
5. received a positive evaluation from two referees/evaluators from two universities in two European Union countries different from the one in which the thesis was discussed;
6. defended the thesis in one of the official languages of the European Union other than that of the country in which the thesis was defended;
7. taken the final exam in front of a Commission made up of at least one member belonging to a university institution of the European Union in a country other than the one in which the thesis was defended.
